UWW Junior WTT Information

2019 UWW Junior Greco-Roman World Team Selection

In Greco-Roman: the winner of the UWW Junior National Championships/UWW Junior World Team Trials will be the UWW Junior World Team Member.

In addition, the runner-up, followed by rank order, will be eligible for the 2019 UWW Junior Greco-Roman Pan American team. This tour is self-funded.

Delay of Final Wrestle-off may only occur in the following situations:

- A delay in a final wrestle-off may occur if a 2018 Junior GR World Medalist is unable to compete for medical reasons. The athlete must provide certified medical documentation in order for the wrestle-off to be considered. Delays **will not be accepted** if received within 48 hours of the scheduled World Team Trials weigh-ins.
- A delay in a final wrestle-off may occur if a 2018 Junior GR World Team Member competes in the April 2019 U.S. Senior Greco-Roman Open.
 - The delay in the wrestle-off for the Junior World Team spot can only occur at the same weight in which the athlete competed at during the 2019 U.S. Senior Greco-Roman Open.
 - If there are multiple 2018 World Team Members that fall into this category and they are at the same weight; there will be a one match wrestle off to see who will challenge the 2019 UWW Junior GR World Team Trials Champion.
- Any delayed wrestle-off for the Junior GR World Team spot will be a best of three series at a time to be determined by the athletes involved as well as National Teams Staff. Any special wrestle-offs will take place prior to July 10, 2019. Flat weight will be required for all wrestle-offs.

UWW Junior Greco-Roman (*only) Division

Qualifying Criteria: Must be born 1999-2001 (2002 with medical certificate) in order to participate.

- Must be a citizen of the United States of America

Event Registration: All athletes wishing to compete at the **UWW Junior World Team Trials** MUST register online via www.themat.com.

Late Registration: Athletes who fail to register online for the trials will be charged all applicable fees and a \$10.00 late fee payable at registration.

To further our chances of performing well at the world level, USA Wrestling will incorporate the Junior Worlds with a mandatory pre-worlds training camp. USA Wrestling is looking to provide an opportunity to compete internationally, as well as provide further training before the Junior World Championships. This may require that some of the funding come from the individuals themselves and/or their clubs or universities.

The camp schedule:

- There will be preparation training camps, focusing on techniques and skills. The athletes will be expected to arrive in competition shape with their weight under control. Hard wrestling will not be required between wrestlers in the same weight category unless requested.
- Any required expenses on the athlete's part will be discussed and guidance will be given to help athletes get expense money together with dates established for receiving any funds needed.

Greco-Roman will have camps prior to departure for the World Championships. Camps will be held at various locations prior to departure for the World Championships. Questions should be directed to Gary Mayabb.
